In the presence of petitioner Smt. K.S. Indira with her counsel Sri. P.K. Ponnappa and the respondent No. 2 the Area Manager (Central), Bangalore Telecom District with their Counsel Sri B. Papegowda for settlement of dispute and both the parties having ~~been~~ filed a joint memo resolving their dispute by settlement before Lok Adalat and the Members having been satisfied that the said settlement is just and fair in the interest of both the parties, it is ordered on the following lines:

The respondents having agreed to restrict their claim to Rs. 11,000/- (Rupees Eleven thousand only) as against Rs. 19,336/- (Rupees Nineteen thousand three hundred and thirty six only), the petitioner shall pay a sum of Rs. 1,337/- (One thousand three hundred and thirty seven only) excluding a sum of Rs. 9,663/- (Rupees nine thousand six hundred and sixty three only) already deposited by her in full and final settlement of the dispute between the parties. The parties have no further claim whatsoever against each other. The joint memo is placed on record.


