CONCILIATION ORDER

Learned Counsel for the appellant and the Insurance Company and Officers of Insurance Company present. 

2. After going through the records and hearing them, it is found that a sum of Rs.25,000/- is found to be just and reasonable compensation and the same shall be deposited in MACT within four weeks from the date of receipt of a copy of the award and this shall not carry any interest.

3. If there is any failure to deposit the said amount within the time stipulated by this Lok Adalath, it shall carry interest at 6% p.a. from the date of default till payment.

As the amount in question does not earn substantial interest, the entire amount shall be paid to the claimant.
