CONCILIATION ORDER

Learned Counsel for the appellant and the Insurance Company and Officers of Insurance Company present.

2. After going through the records and hearing them, it is found that a sum of Rs.30,000/- is found to be just and reasonable compensation and the same shall be deposited in MACT within four weeks from the date of receipt of a copy of the award and this shall not carry any interest. *ch*

3. If there is any failure to deposit the said amount within the time stipulated by this Lok Adalath, it shall carry interest at 6% p.a. from the date of default till payment.

As the amount in question does not earn substantial interest, the entire amount shall be paid to the claimant.
