THIS MFA IS FILED UNDER SECTION 173 (1) OF MV ACT AGAINST THE JUDGMENT AND AWARD DATED 26.03.2010 PASSED IN MVC NO.395/2008 ON THE FILE OF ADDL. DISTRICT JUDGE (MACT) RAICHUR, PARTLY ALLOWING THE CLAIM PETITION AND SEEKING ENHANCEMENT OF COMPENSATION.

THIS M.F.A BEING REFERRED TO LOK-ADALAT COMING ON FOR CONCILIATION THIS DAY, THE LOK ADALAT MADE THE FOLLOWING:-

CONCILIATION ORDER

Appellant-claimant and her learned counsel are present. Learned counsel for the 1<sup>st</sup> Respondent-Insurance Company and the representative of the Insurance Company are present.

2. After protracted negotiation, the matter is settled. The appellant-claimant has agreed to receive a total compensation of Rs.2,25,000/- (Rupees Two Lakhs Twenty Five Thousand Only) in addition to the amount awarded by the MACT, Raichur, in full and final settlement of the claim and the 1<sup>st</sup> Respondent-Insurance Company has agreed to pay the same. A joint memo is filed on behalf of the parties to this effect.

3. The 1<sup>st</sup> respondent -Insurance Company has agreed to deposit the said amount within six weeks from the date of



preparation of award, failing which, the said amount shall carry interest at 9% pa from the date of default, till the date of deposit.

4. The MFA stands disposed of in terms of the joint memo. The award of the Tribunal. shall stand modified accordingly. Draw-up the award accordingly.
